### **State Board of Optometry**

This includes the successful completion of NBEO Part I, II, III, TMOD, and passing the California law exam administered through the state board. They must have graduated from an Accreditation Council on Optometric Education (ACOE) accredited school or college of optometry with an OD degree with a cumulative GPA of at least 3.0 (on a 4.0 scale) in the optometry professional curriculum.
