For a typical applicant, an I-485 checklist of supporting documents should include: Government-issued Photo ID. Submit a copy of a government-issued photo identity document such as a passport or driver's license. Passport-Style Photos.

### I-485 Checklist for Family-Based Applications | CitizenPath

The I-485 application needs to be filed with supporting documents to prove that the applicant is eligible for a green card. The following supporting documents must be included with a marriage-based I-485 application:

### U.S. Immigration Form I-485, Adjustment of Status - Boundless

Applying to become a lawful permanent resident in the United States means submitting the Form I-485 with it's required supporting documents (Form I-130, Form I-693, Form I-864, etc.) to USCIS. If your petitioner is an immediate family member, you can submit all the paperwork and forms together at one time.

### Form I-485 Step by Step Instructions - SimpleCitizen

If you are the child, a copy of your birth certificate. If the primary applicant is not your parent, submit copies of evidence (such as a marriage certificate and documents showing the legal termination of all other marriages and an adoption decree) to demonstrate that you qualify as his or her child.

### Filing I-485 for Dependents of Primary Applicant - Immihelp

If you properly file Form I-485, Application to Register Permanent Residence or Adjust Status, USCIS will initially respond by mailing you a receipt notice that confirms receipt of your application. Formally known as Form I-797C, Notice of Action (see example below), the receipt notice typically arrives 2 to 3 weeks after filing. If you did not properly file your Form I-485, USCIS will send a Notice of Action to reject the application or may send a Request for Evidence that requests ...

### Adjustment of Status | USCIS

Form I-485 is the primary application form used by would-be immigrants who are: eligible to apply for a U.S. green card (lawful permanent residence), and; also eligible to do so while living in the U.S., without leaving for an overseas consular interview.

### What You Need to File I-485 for Adjustment of Status | AllLaw

If the priority date is current, you can concurrently file Form I-485 with Form I-140. For those whose I-140 is pending, I-485 can also be filed prior to the approval of I-140. Receipt notice I-797 for I-140 must be submitted along with I-485 application to establish the eligibility.

### Adjustment of Status (I-485) Application Procedure

The only additional document that you must submit with your Form I-485 is a document showing that you were granted asylum, such as a USCIS approval notice or an immigration judge order. Likewise, if you were admitted to the U.S. as a refugee, you can apply for a green card one year after receiving refugee status, if you have maintained your status.

Certain foreign nationals inside the United States use Form I-485, Application to Register Permanent Residence or Adjust Status, to apply for a green card. "Adjustment of status" is a common term used to describe a change in U.S. immigration status to permanent residence (green card holder). U.S. immigration law allows a temporary visitor (e.g. student, tourist, etc.) to change status to a ...

### What is Form I-485, Application to Adjust Status ...

Evidence to File with Form I-485. You may need submit evidence of your principal or derivative applicant status. Applicants filing Form I-130 concurrently with Form I-485 can disregard this requirement. However, any principal applicant with a pending or approved immigration petition, should submit the receipt or approval notice.

Here are the basic documents required in every I-458: Fee payment - The application fee must be included. Form G28 (if applicable) - This form confirms that someone like an attorney or a representative files on your behalf. I-485 - The application to register Permanent Residence or to Adjust Status.

### The COMPLETE Guide to Form I-485 for Immigrants and Visa ...

Alternately, any government issued document with photo on it is acceptable e.g. drivers license. Copy of Green Card applicant's Birth Certificate. If birth certificate is not available, refer to Form I-485 instructions for equivalent documents. Copy of Green Card applicant's I-94 and Visa Stamp, if available.
